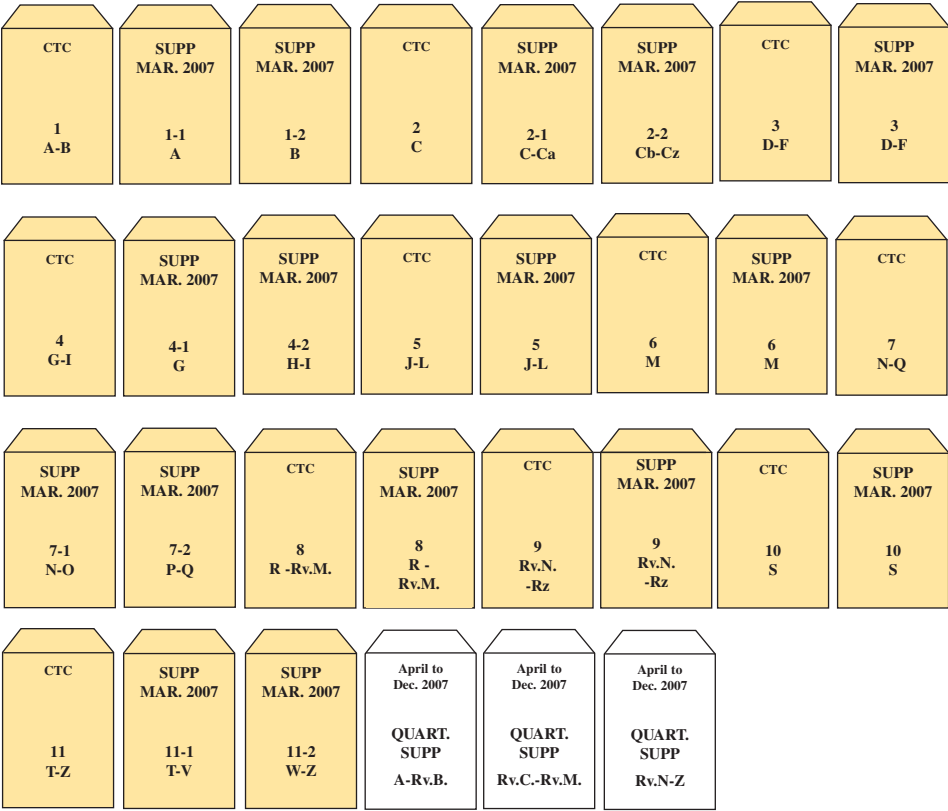


THE CANADIAN ABRIDGMENT SHELVING DIAGRAM

CONSOLIDATED TABLE OF CASES - Each of the eleven hardcover volumes is supplemented by one or more annual cumulative softcover volume(s) covering to March of each year. A cumulative quarterly softcover supplement is issued three times per year at three-month intervals. The third cumulative supplement is replaced by the annual supplement in the twelfth month. Monthly updates appear in Canadian Current Law - Case Digests.



CASE DIGESTS – At the end of December 2007, Carswell completed its five-year project to replace the Second Edition of the Canadian Abridgment with the Third Edition. The Case Digests, Third Edition now consists of 155 hardcover volumes. Each hardcover volume is supplemented by a single softcover volume that updates it to December of the previous year. These supplement volumes are replaced on a cumulative basis once a year. Supplement volumes for the last Third Edition hardcover volumes will be published in the spring of 2008.

The Case Digests volumes are accompanied by the Key & Research Guide binder, General Index binder and Case Law Update binder. Monthly updates of the Case Digests appear in Canadian Current Law – Case Digests.
